I hereby enter the above at my own risk, subject to the rules of Fieldcrest Farm, and engage to be responsible for any injury or damages that may occur to or be so caused by any animals, vehicles, or trappings, or the loss of any animals, vehicles or trappings exhibited by me, and I further agree to be absolutely responsible for the physical condition of any animal under my control or ownership. I also certify that any animal exhibited by me is free of any infectious or contagious disease, and possesses a current Coggins test. Under Massachusetts Law, an equine professional is not liable for any injury or the death of, a participant in equine activities from the inherent risks of Equine Activities pursuant to Section 2D of Chapter 128 of the General Laws.
