LIABILITY RELEASE

I hereby release Amerikhana Games on Horseback, Inc., its officers, members, agents and volunteers, plus any and all landowners involved in this riding event, from any and all liability for injury, damages or harm that may occur to me, to the horse I am using, or to the property owned or used by me. Further, I represent that I understand the hazardous nature of using horses, including pleasure riding, in which injury can occur to the horse and rider due to vehicles, natural and man-made obstacles or materials, other horses, dogs, storms, groundhog holes, cattle stress and other hazards. My horse is in good enough condition and fit enough to undertake the distance I have selected to go, and I have reasonable control of the horse so as to avoid risk of injury to others. I also warrant that I have a current negative Coggins test on this horse (according to state law).

I realize that all necessary precautions should be taken for safety, such as wearing a hard hat, helmet and proper riding footwear. However, if I wish to ride without exercising these safety measures I do so that my own risk.

In the event of any conflict between the various forms, The Massachusetts Law and releases on the reverse side will apply.

Release and Waiver of Liability

I am aware that horseback riding is an athletic event which poses potentially serious risks of injuries or death to its participants. I understand that my horse or I may be injured or die as a result of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I am going to be engaged. I also understand that horses even the most well trained are often unpredictable and often difficult to control.

With this waiver, I accept notice of the provisions under M.G.L.C. 128, SECTION 2D Of Massachusetts law, which state in part, that there are inherent risks in equine activities, including (1) the propensity of equine to behave in dangerous ways which may result in injury to the participant, the inability to predict an equine's reaction to sound, movements, objects, persons or animals and hazards of surface or subsurface conditions. The waiver shall remain valid unless expressly revoked by the participant or parent or guardian of a minor, in writing with receipt acknowledge by the Amerikhana Games on Horseback, Inc. and its officers.

Furthermore, with this document, I expressly assume the risk of injury or death due to negligence by Amerikhana Games on Horseback, Inc., its officers, directors, members, agents, employees, staff or guests for my own safety or the safety of my minor child.

With the knowledge of the foregoing as an inducement for the officers, directors, and members of Amerikhana Games on Horseback, Inc., I hereby agree to waive or release (give up) any rights that I or my heirs may have to make a claim against Amerikhana Games on Horseback, Inc. or its members and participants arising from any damages, injury or death which I might sustain or which might occur to any horse I am riding as a result of my horseback riding. I further agree to indemnify (hold harmless) all of the foregoing from any claims which I might make or which might be made on behalf of others or which might be made against me by others arising from riding with the Amerikhana Games on Horseback, Inc. club or following or participating on foot or by automobile. Furthermore, I agree to indemnify Amerikhana Games on Horseback, Inc. and its members for any injury, death, loss of or damage to any personal property which might occur during riding or social functions sponsored by Amerikhana Games on Horseback, Inc. or held on its behalf or for its benefit.

By signing this release and waiver, I understand that I am giving up (waiving and releasing) any right I have to sue or make a claim which I might have or which might subsequently arise or occur against the Amerikhana Games on Horseback, Inc. and its officers, its members and participants for any injuries I might sustain while horseback riding or following or participating on foot or by automobile and that I am indemnifying (holding harmless) Amerikhana Games on Horseback, Inc. and its officers, its members and participants for injuring anyone else or any horse ridden by another while so engaged. It is my intent to give up those rights and provide the hold harmless agreement and I do so knowingly and voluntarily.
